






#### **Early Childhood and Family Mental Health Credential (ECFMHC)**

Seven people received their Early Childhood and Family Mental Health credential in 2022. A new cohort of eight people began the process in this past fall, and will receive their credential in the fall of 2023. We thank the Bureau of Child Development for funding this cohort, and for supporting our efforts to update and revise the ECFMCH competencies and the credentialing processes. Over the next year, we seek to increase the pool of available Reflective Practice Consultants and expand the availability of the credential. Stay Tuned.

#### **2022 Annual Conference**

In 2022 we held our first in-person conference in three years! For two days, we sat together, learned, discussed and networked on the beautiful shore of Lake Winnipesauke. Our conference theme was: "From Community to Clinic: Best Practices in Early Identification", with sessions brought to us by a variety of knowledgeable presenters. Our keynote speaker was Alice S. Carter, PhD, Professor of Psychology at the University of Massachusetts Boston.

We had a total of 76 attendees who participated in a total of 11 sessions on the topics of early screening practices, maternal mental health, navigating systems of care, early childhood education, and early childhood trauma, among others. Attendees also received a participatory presentation on incorporating mindfulness in their careers. It was wonderful to see everyone in person, and the Knowledge and Education Committee learned a lot from the experience.

### **Committee Updates**

#### **Leadership and Governance Committee**

Organization was the 2022 "word of the year" for the Leadership and Governance Committee. With all of the agencies, government departments, and vendors NHAIMH interacts with throughout the course of the important work our organization does, we decided it was time to have pertinent information complied in a more organized way. The committee created a master list which included: the demographic info for contacts we work with, important information regarding our contracts, a place to record interactions with agencies, vendors, etc., a running list of bills and invoices, and bank accounts connected to the association It is our hope that having this comprehensive list will be a useful tool both now and in the years to come.

The Leadership and Governance committee also spent time reviewing and revising important documents. Time and effort was put into revising policies and procedures related to the NHAIMH Community Education and Awareness Activities mini grants. Also, the "Guidebook for NH Charitable Foundations" was reviewed carefully to be sure our activities were in keeping with all that is expected of NH non-profits. Thanks to the hard work by the Leadership and Governance committee this year, five key points have been recommended to the Board of Directors for consideration. It has been decided that the first point of action for the Board of Directors will be to revisit the process of orientation of new members who join NHAIMH.

## **Knowledge and Education Committee**

The focus of the work done by the Knowledge and Education Committee in 2022 was planning the NHAIMH Conference in Meredith, NH at Mill Falls. Our committee strove to offer informative and educational topics in an environment where participants could connect and network with peers. After several conferences that were unable to be together, we were thrilled to host this in person event.

Evaluations of the conference were very positive. Attendees provided us with some ideas for improvements in the future. Plans for the 2023 conference are already underway. Due to the high cost of attending the Mill Falls Venue, we have settled on a more affordable option for next year's conference, with a plan to shift locations around the state in the coming years.

#### **Public Awareness Committee**

We have two new members who have joined our committee this year! We are now meeting regularly on the second Tuesday from 8:30 am to 9:30 am. We have lots of great ideas in this group. Our meetings are jam packed with energy and suggestions. We have decided to engage more help with setting up regular and interesting Facebook posts, so keep a look out! We continue to have the most community exposure when we highlight NH Early Childhood professionals and when we get the word out about workshops and conference presenters. Finally, we are very pleased that this year we had renewed interest and enthusiasm for our Award of Excellence.

### **Development & Fundraising Committee**

In 2022 the Development & Fundraising committee met virtually on the 3rd Tuesday of the month. Efforts continued to focus on increasing membership.
